## The Great Start Readiness Program

is a **tuition-FREE Preschool** that prepares children for kindergarten. Eligible students are children living in Monroe County who attain age 4 by September 1st of the current school year.\*

This high-quality preschool program explores the content areas of literacy, math, science, and social studies through active learning experiences. Children develop language and problem solving skills through peer interactions and play. The curriculum is aligned with the Early Childhood Standards of Quality for Pre-kindergarten.

The **Great Start Readiness Program** is funded by a grant from the Michigan Department of Education. The State has identified factors that may affect your child's education at any time in his/her kindergarten through 12th grade school career.

### Children with any of the following factors will be considered for the program:

- Your child has a developmental delay.
- Your child has challenging behavior.
- Your family's primary language is not English.
- You do not have a high school diploma or GED.
- Your child has experienced abuse/neglect or there is domestic violence in the home
- Environmental risk factor(s) are present in the home.
- **Your family meets the income guidelines listed above.**
